## **PUBLIC SPACES PROTECTION ORDER 2026 NO.008 (VARIATION)**

### **TO PUBLIC SPACES PROTECTION ORDER 2024 NO.004 (FIRES, BARBEQUES, VEHICLES AND STRUCTURES)**

#### **ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014**

**THIS ORDER** is made by Westmorland and Furness Council (“the Council”) in exercise of its powers under section 61 of the Anti-Social Behaviour, Crime and Policing Act 2014 (“the Act”), hereby makes the following Order:-

#### **1. Citation and Commencement**

**THIS ORDER** may be cited as the Public Spaces Protection Order (Fires, Barbeques, Vehicles and Structures) (Variation) 2026 No.008 and shall come into force on [INSERT DATE].

#### **2. Variation to Public Spaces Protection Order 2024 No.004**

The Council hereby varies the Public Spaces Protection Order 2024 No.004 (Fires, Barbeques, Vehicles and Structures) (“the Original Order”), as previously varied, as follows:

##### **2.1 Variation to Schedule 2B**

Schedule 2B of the Original Order is hereby amended by the insertion of the following clarification at the beginning of Schedule 2B:

“For the purposes of clauses 2.1.1, 2.2.2 and 2.2.3 of this Order, where land listed in this Schedule is not owned or managed by Westmorland and Furness Council, any reference to consent from the National Trust shall be read as consent from the relevant landowner or land manager.”



## 2.2 Addition of Locations to Schedule 2B

The following locations shall be added to Schedule 2B of the Original Order and shall be subject to clauses 2.1.1, 2.2.2 and 2.2.3 of the Order:

- Ambleside – Galava Roman Fort – National Trust land, as shown edged red on the map titled “*Galava Roman Fort, Ambleside PSPO Map*” (Appendix 5)
- Ambleside – Holme Crag – National Trust land, as shown edged red on the map titled “*Holme Crag, Ambleside PSPO Map*” (Appendix 6)
- Hartsop – Brotherswater – National Trust land, as shown edged red on the map titled “*Brotherswater, Hartsop PSPO Map*” (Appendix 7)
- Coniston Water – Brown Howe – Lake District National Park Authority land, as shown edged red on the map titled “*Brown Howe, Coniston Water PSPO Map*” (Appendix 8)
- Haweswater Reservoir – United Utilities land, as shown edged red on the map titled “*Haweswater PSPO Map*” (Appendix 9)
- Ullswater – South Ullswater including Glencoyne and Aira Force – National Trust land, as shown edged red on the map titled “*South Ullswater (Glencoyne & Aira Force) PSPO Map*” (Appendix 10)
- Ullswater – South Ullswater including Ullswater Steamers land and Jenkin Field, Glenridding – Lake District Estates, National Trust and Patterdale Parish Council land, as shown edged red on the map titled “*South Ullswater (Glenridding & Patterdale) PSPO Map*” (Appendix 11)
- Ullswater – Laybys and land adjacent to the lake – Gowbarrow Hall land, as shown edged red on the map titled “*Ullswater Gowbarrow Hall PSPO Map*” (Appendix 12)
- Windermere – Bowness and Millerground including Cockshot Point – National Trust land, as shown edged red on the map titled “*Bowness & Millerground PSPO Map*” (Appendix 13)

Each location listed above is shown edged red on the maps attached to this Order at Appendices 5 to 13.



**Note:** The areas listed in Schedule 2B include land not owned or managed by the Council. These areas are included in this Order with the formal written consent of the landowner or land manager and following statutory consultation under section 72 of the Act.

### 3. General

This Variation Order is made in accordance with the procedure set out in sections 60 to 61 of the Act. The provisions of the Original Order shall continue in full force and effect, save as expressly varied by this Order.

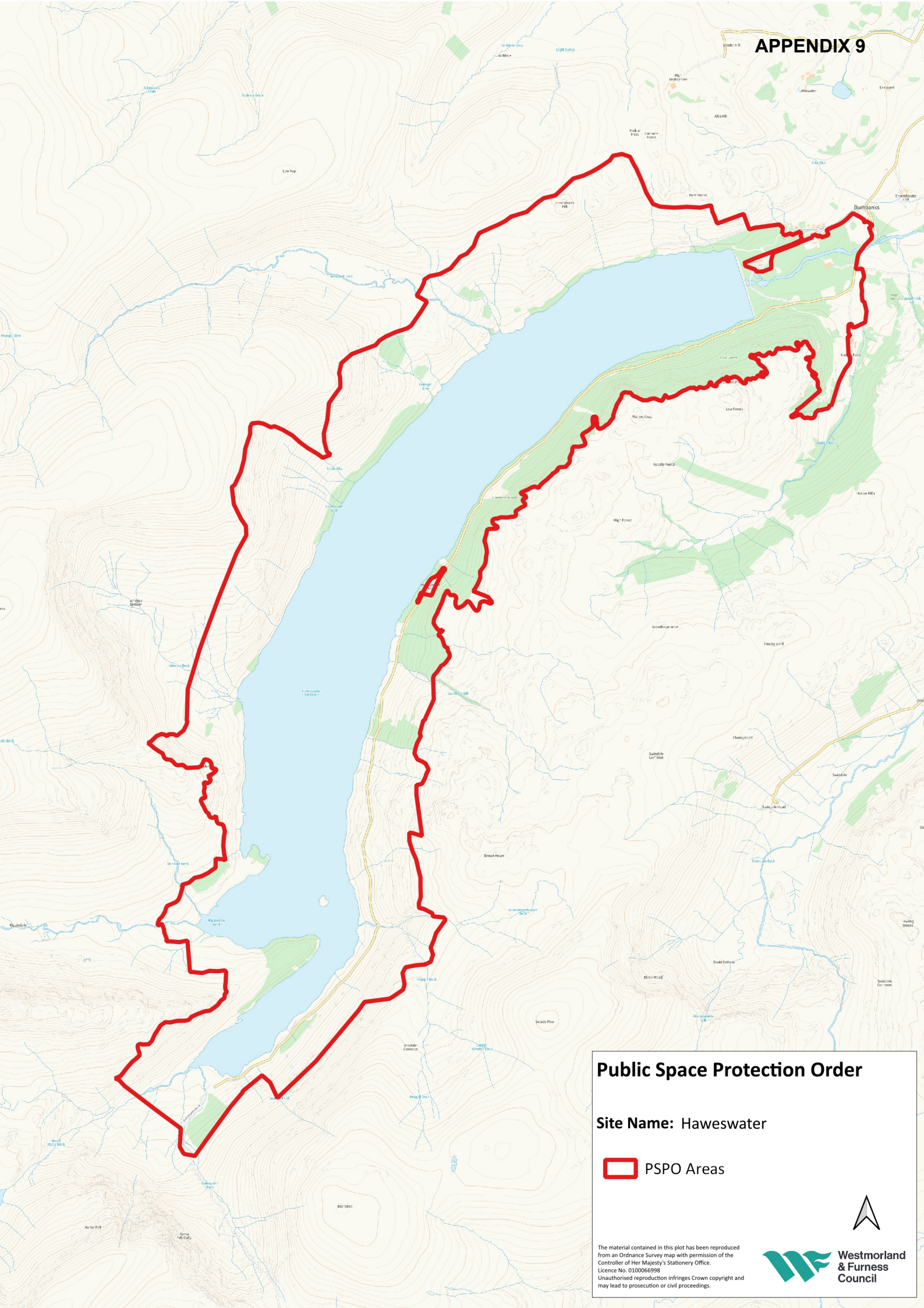

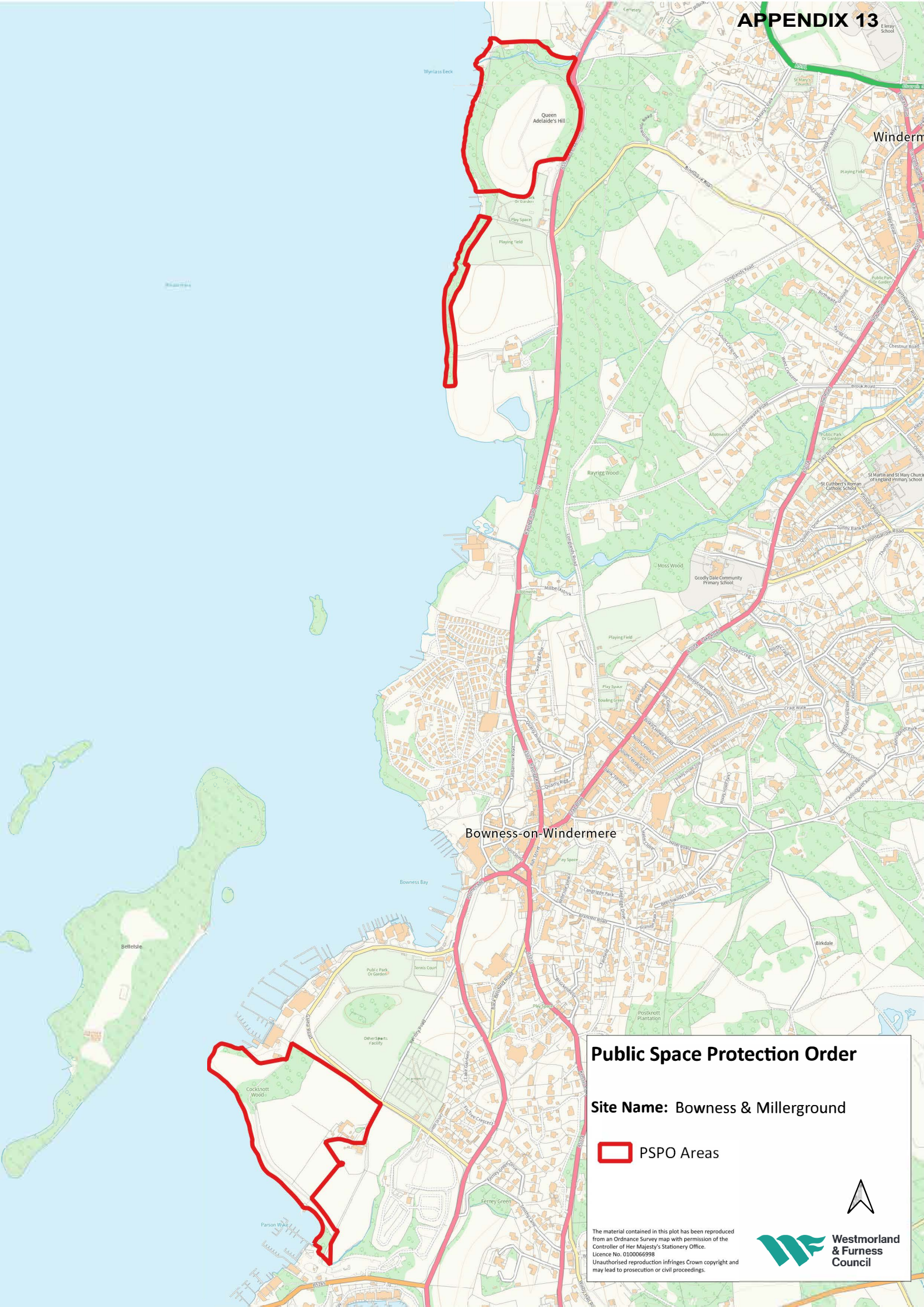
